3. EXCLUSIVITY

During the Due Diligence Period and for [EXCLUSIVITY DAYS] days thereafter, the Company agrees not to solicit, negotiate, or enter into any agreement with any other party regarding the sale, transfer, or financing of the Company or its assets ("Exclusivity Period").

4. CONFIDENTIALITY

Both Parties agree to keep the existence and terms of this LOI strictly confidential and not to disclose them to any third party without the prior written consent of the other Party.

5. NON-BINDING NATURE

This LOI is non-binding and is intended solely to express the Parties' mutual intent to negotiate in good faith toward a definitive agreement. Neither Party shall be legally obligated to consummate the proposed transaction until a definitive agreement is fully executed.

6. EXPIRATION
