INDEPENDENT CONTRACTOR AGREEMENT

Contractor agrees to hold all information relating to Client's business, clients, and operations in strict confidence and not to disclose such information to any third party during or after the term of this Agreement.

5. INTELLECTUAL PROPERTY

All work product, inventions, and deliverables created by Contractor in the performance of the Services shall be considered works made for hire and shall be the exclusive property of Client.

6. TERM AND TERMINATION
